Modulated Fees Vision Event

Productive discussion on:


- moving beyond recyclability

Background

Defra commissioned Ipsos, in partnership with Ricardo and Technopolis, to carry out an evaluation of the R&WS over a five-year period, starting in February 2022, during which key policies will be developed and implemented.

The aim of the evaluation is to help Defra understand what has and has not been successful about the design and delivery of objectives and commitments within the R&WS, why and for whom.

- Five impact evaluations covering high-level outcomes of the policies.
- 12 light-touch evaluations of key policies (process evaluations) that Defra will implement over the lifetime of the evaluation, kicked off at least six months after the policy's implementation, with the aim of understanding the initial outcomes of the policy and indicative progress towards longerterm outcomes.
- An economic evaluation, comprising estimates of the cost/benefit ratio of the progress to date towards achieving the policy outcomes.



Impact Evaluation - Policy Outcomes (POs)

- PO1 More products are regularly retained, reused, repurposed, refurbished, or remanufactured
- PO2/3 Recycling rates for households, businesses, and municipal waste increase and Household, municipal and business waste streams improve in quality
- PO4 Plastic waste and plastic pollution is reduced
- PO5 Waste crime is reduced
- PO6 Eliminate food waste to landfill by 2030



Policy Evaluations

- Single-use plastics ban, implemented in October 2023
- Carriers, Brokers and Dealers (CBD)
- Enhanced Approach to Businesses Reporting Food Waste
- Packaging Extended Producer Responsibility (pEPR)
- Waste Tracking Exemptions

- Simpler Recycling
- Deposit Return Scheme (DRS)
- Waste Electrical and Electronic Equipment recycling (WEEE)
- End of Life Vehicles (ELV)
- Batteries
- Textiles

Areas for which data are collected:

- Consumer awareness and choices related to waste, resource use and sustainability
- Business behaviour change related to product design (eco-design) and sustainable business models and operational processes
- Use of reusable, recyclable and recycled materials

- Changes to waste streams (including food waste)
- Regulatory requirements
- Recycling technology
- Waste management capacity and capabilities

Who	Detail	Aim
Waste businesses survey	Businesses dealing with waste collection, waste transport, waste management, waste disposal)	Assess changes in waste management practices
Product & packaging producers survey	Manufacturers of packaging, products, brand owners and importers of packaged goods	Assess changes in product packaging and packaging design practice
Food and beverage retailers survey	Retail shops selling food and beverages, hotels, cafes, restaurants and bars	Assess changes in packaging design and product packaging choices, as well as DRS impacts (once policy is implemented)
EEE, batteries, textiles business survey	Producers and retailers of electrical and electronic equipment (EEE), batteries and textile products in England	Track business practices for production, repair, and refurbishment of these products. This is an England only survey.
Waste generating business survey	Businesses who produce household-like waste such as office-based companies/locations – formally classed as generators of non-household municipal waste	Assess changes in waste separation practices and explore considerations of sustainability in business models/operations

Next steps:

- The survey will be launched in mid-November
- Collect feedback from business associations and Defra policy teams
- Data analysis and triangulation with financial information and other existing data sources

Disposable Vapes

Disposable Vapes

- The government has launched a consultation seeking views on plans to crack down on youth vaping in the next steps to create the first smokefree generation
- The consultation was launched on 12 October 2023 and includes proposals to restrict child-friendly flavours and bright coloured packaging
- The introduction of cheap and accessible disposable vape products is also causing major environmental harm
- The proposals will be a major benefit to the environment by tackling a problematic waste stream
- The consultation closes on 11:59pm on 6 December 2023
- This update was published in the recent R&W Newsletter and had the links to the consultation
